Answers from Stacy Garrity

1. What qualifies you to be the top financial officer in the state?

I bring to this office a combination of discipline and mission-forward focus developed during a career in the U.S. Army Reserves, including three tours of duty in Iraq, where I was awarded two Bronze Stars and the Legion of Merit. At home, I developed business and financial skills as one of the first women to rise to the rank of vice-president at Global Tungsten, a Pennsylvania-based metals firm doing business around the world.

My experience in office has been guided by a taxpayer-centered policy of maximizing earnings on state investments while respecting the values of our commonwealth. As such, I have worked with members of both parties to reform the investment policies of our two state pension boards, established new records for the return of lost and abandoned property, reduced fees for participants of our PA 529 college savings program while earning its first-ever Gold rating from Morningstar, the investment ratings agency.

2. What are your top 3 priorities if you are elected/re-elected?

My priorities are to build on my office's success in returning unclaimed property, characterized by my advocacy for legislation that allows Treasury to proactively return this property to its rightful owners. Additionally, I plan to continue expansion of our PA ABLE Program which allows Pennsylvanians with special needs to earn income without losing benefits - a program that provides both a higher standard of living and the dignity of work for those who are able to participate in the workforce. It is also my plan to intensify the laser focus Treasury now has in maximizing earnings on investments of the approximately \$50 billion in discretionary revenue overseen by Treasury.

3. What are a couple practical ways to help struggling citizens in this economic climate?

The State Treasurer doesn't have a vote on laws in the legislature. However, I make it a priority to speak with Pennsylvanians in every corner of Pennsylvania about their concerns and ideas for how to strengthen Pennsylvania's economy. I have visited all 67 counties every year, and these conversations have provided invaluable insight that I am eager to share with members of the state house and senate.

One practical way my office helps folks cope with the current economic climate is through the return of unclaimed property. Typically in the form of money, this influx of cash can help to mitigate the effects of inflation. While this is money that belongs to the folks that it is being returned to, it is one practical way that my office can help get additional funds into the hands of my fellow Pennsylvanians. And we have done an extraordinary job in doing so: last year, my office broke the record for the most amount of unclaimed property returned in a single year - \$273 million.
